ATTENDANCE AND HOURS

- Volunteers are responsible for logging their own hours in the Volunteer Binder (inside the Carriage House). We know many youth have to document their hours for school and museums keep these time logs for grants and other reporting.
- Volunteers are also expected to show up for the event or project they signed up for and in a timely manner. If you are unable to attend an event previously agreed upon, it is your responsibility to reach out and let us know.

AVRR (AUBURN VALLEY RAILROAD)

- Youth volunteering with the AVRR will have additional expectations and rules, mainly for their safety and the safety of others. All volunteers with the AVRR will receive a copy of the AVRR Handbook and Rulebook.
- The AVRR operates during special events (Egg Hunts, Train Day, Steamin' Day and the Auburn Heights Invitational). They also have regularly scheduled work sessions on Mondays, Wednesdays and Fridays from 9 am noon.

DRESS CODE

- When volunteering in general here, please remember to dress comfortably, but professionally. Comfortable, casual clothes may be worn, especially for programs that are messy, but remember to dress appropriately.
- T-shirts, jeans, and sneakers are appropriate for most events. We ask that if you have a Marshall Steam Museum logoed shirt (available for an additional fee) that you wear it for any event or program you are volunteering with.
- If volunteering with the AVRR, you should follow their dress code, as outlined in the AVRR Handbook.

MEMBERSHIP

- All volunteers who work with our collection (antique autos and the trains/AVRR) must be a museum member at any level. A youth volunteer can be covered under a Family Membership.
- After 25 hours of volunteer work, your child can then qualify for a Family Membership at the discounted rate of \$30 the following year.

MISC

- We encourage all our volunteers to get involved in a variety of roles and projects on site! Please reach out or look for additional opportunities on our website and emails.
- Monthly volunteer emails are sent out mid-month in addition to follow-up emails for certain roles or projects. Yearly site-wide training typically occurs in the spring.
- The first Friday in December we hold a special volunteer holiday party in the museum. Put it on your calendars as we hope you'll be able to join us!

YOUTH VOLUNTEER AGREEMENT

As a volunteer you are an important part of the organization and serve as a representative for us at all times. We care about your growth and aim to aid in your professional development and the fostering of skills that can be applied to future careers.
